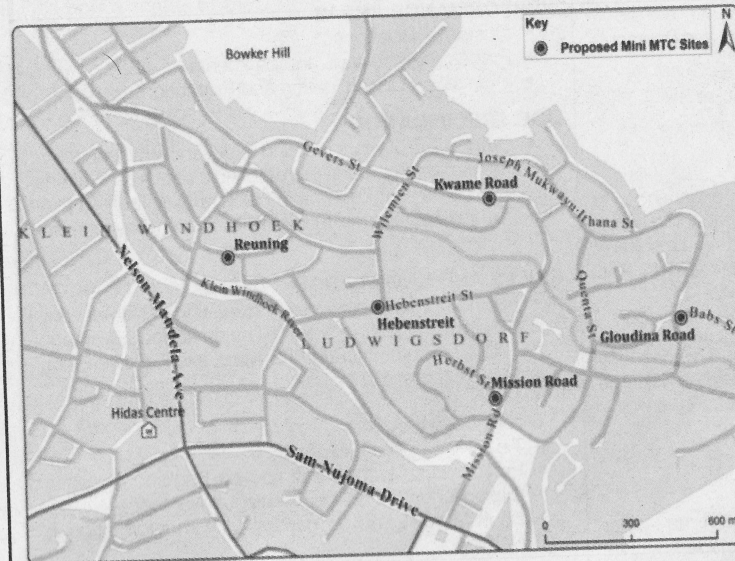

### PROPOSED CONSTRUCTION OF FIVE MTC MINI BTS SITES IN LUDWIGSDORF, WINDHOEK
